

Legislative Advocacy Day 2010: Health & Environmental Impact on Student Achievement

Since the "Corridor of Shame" production highlighted the condition of education in South Carolina, more attention is now being focused on the conditions surrounding students and their families that impact performance at school. Following that interest, the 2010 Legislative Advocacy Day is structured around questions of health and the environment, and what we know that affects how well students perform in school. Join your branch colleagues at the Columbia Marriott on February 23 to learn about the policies that our legislators should address to make improvements.

Leading off the morning, **Dr. Oscar Lovelace**, child health advocate and practitioner, will focus our attention on the cost to our children when they lack access to timely health care. The former candidate for governor is a passionate speaker and will set the tone for the day's considerations.

Nancy Vinson, program director for the Coastal Conservation League, will focus our attention on air and water quality related to public health. The issues are usually community based and affect everyone, but children have little influence on changes in their environment that would improve their school performance.

Dr. Tiffany Williams, MUSC College of Nursing, will moderate a panel to highlight several health issues facing South Carolina children. Dr. James Stallworth, USC pediatrics professor, will outline the issues around nutrition and child obesity, and Zenica Chapman, from the SC Campaign to Prevent Teen Pregnancy, will focus our attention on the diseases associated with early sexual activity. **Cindy Poole**, assistant executive director and midlands coordinator of Healthy Learners, will outline the actions being taken in several locations around the state to mitigate the lack of access to health care and/or identifying health issues that can be treated.

"So how do we pay for these changes? We don't have any money." says the hypothetical legislator. Reconfiguring the current taxes is one answer to that response and the lunch speaker, **Dr. Michael Fanning**, executive director of the Olde English Consortium, will provide an insightful and energizing look at how we can direct legislators' attention to millions of dollars requiring their action to make it available.

Plan now to attend and make appointments to meet with your local legislator that day in Columbia. Legislative Advocacy Day promises to be lively and thought-provoking, providing the basis for effective advocacy in the General Assembly.

Change has come to AAUW and AAUW of SC

Change had been the byword of AAUW for the past several years. We have seen changes in the organization of AAUW with the merging of funds and boards. The membership voted for changes in the bylaws which, among other changes, now provide for one member, one vote and the ability to reorganize our branch and state structures.

Also over the past several years, some branches in South Carolina have changed the structure of their leadership with leadership teams now being used instead of defined officers. Many branches are becoming more project-oriented rather than having regular monthly programs.

Now most of us are faced with many changes in our lives. My husband and I were planning our retirement when the recession hit like a thunderbolt. Like many, we were faced with a drastic change in our income. Members of our family have had changes, too, with lost jobs, decreasing incomes and financial worries.

Now, more than ever, the advancement of women in the workplace is important. According to a study done by Maria Shriver, women are more likely than ever to head their families; half those women who are primary breadwinners are also single mothers. Seventy percent of families with kids include a working mother.

According to *Time* magazine, 60% of men are convinced that there are no longer any barriers to women's advancement in the workplace. Yet, women *still* don't make as much as men do for the same jobs. The U.S. is *still* the only industrialized nation without a child-care policy. Women are *still* disproportionately affected by a lack of health-care services. Women are *still* being punished by a tax code designed when men were the sole breadwinners and women the sole caregivers.

What does this have to do with our commitment to AAUW? The barriers prohibiting us from reaching our full potential must be eliminated. AAUW is whittling away at these barriers piece by piece.

By being members of AAUW, we are supporting women throughout the country. By using the *Two Minute Activist*, we are making sure our voices are heard. Branches contribute \$11,669 to launch endowment

When it comes to the Power of the Purse, AAUW of South Carolina always shows that it has what it takes.

Since announcing during the 2009 state Spring convention that AAUW of SC would establish the Betty Bayless Research and Projects Grant, branches and contributed individuals have \$11,669.46 to help start the process.

Several Branches came up with very creative ways to raise the funds in Betty's honor. My favorite was the Charleston Branch doing a dinner based on the recipes from Julia Child's Art of French Cooking. What a fun way to raise money and eat good food at the same time.

The Research and Projects Grant is a \$75,000.00 endowment

that requires the state to raise \$5,000.00 to start it and it must be completed in ten years. South Carolina historically completes grants well before the deadline. Betty's grant is a Community Action Grant.

Since the inauguration of the Research & Projects Fund in 1972, AAUW has provided support to hundreds of communities around the US to advance education and equity for women and girls. Early projects focused on public interest issues, including women's struggles to balance home and work life, the establishment of women's resource centers on college campuses, and the emergence of women's political involvement in the anti-nuclear movement.

As the program evolved and grew, AAUW explored ways to strengthen support for community-based programs that further its mission. Projects have become increasingly collaborative and girl-focused, bringing together AAUW branches and local community groups.

In 2006, AAUW supported the Girls Excelling in Math and Science (GEMS) program, a partnership between the AAUW College Park MD Branch and the University of Maryland. The project provided hands-on science exploration and mentoring for D.C. area middle-school girls.

Thanks to a 2007 Community Action Grant, the antibullying Ophelia Project of Southeast Wisconsin was able to expand its reach, creating new partnerships with schools, AAUW chapters, as well as the Girl Scouts of Wisconsin.

Let's Read Math, a project funded in 2005 that works with AAUW branches to partner with local community organizations to offer math skill-building curriculum for young children, continues to grow and thrive.

The 2009 grant recipients are undertaking exciting projects, such as a nine-week intensive college preparatory program for young women who have completed their GED; an after school program that focuses on aviation career education for middle school girls; a summer science camp for lowincome 11th & 12th grade female students; and an initiative to recruit women coaches for after-school programs throughout California in order to help develop and encourage girls' participation in sports.

I want to thank all of you for your hard work and willingness in this economy to open your purses and give so Betty's legacy of working for equality for women and girls will continue.
