Complete reorganization of AAUW of SC to be voted upon at Spring Convention – check out the proposed plan

A task force of the AAUW of SC Board has taken a look at the current bylaws of the organization to see where things could be streamlined for more ease of leadership. Increasingly over recent years, it has been harder and harder to find AAUW members willing to take leadership positions at the state level.

Members of the task force – Pat Batten, Pat Hall, Bev James and Ann Terry – determined after study of other state structures that a reorganization of SC's structure would make it a more effective model for continuing a state organization.

This decision meant a complete overhaul of the state bylaws, which also needed revisions based upon mandatory changes from national organization and need for compliance with SC state codes relative to non-profit organizations. The proposed new structure is outlined in the proposed bylaws which you will find inserted in this issue. It is required that every member receive notification of changes to the state bylaws. Vote will be held on April 21.

Major highlights of the new structure include:

- Three elected officers President, Finance Officer and Past President
- Six standing committees to handle work of state -Advocacy, AAUW Funds, Communications, Member Support, Nominations and State Meetings
- State conventions held only in even years

Please take the time to review these proposed changes and come to convention to join the discussion. Your decision will shape AAUW of SC's future.

Speakers' Profiles

Kathryn (Kat) Braeman

Kat was appointed in 2011 to the national board of AAUW as a Director-at-Large. She is committed to expanding opportunities for AAUW leaders and to being an advocate for equity. Janice Dyer

Janice started the *Lowcountry Coalition Against Human Trafficking* in February of 2010. The organization was originally sponsored by the Zonta Club of Hilton Head. A 501(c)(3) non-profit organization, its mission is to provide community awareness of this crime and to advocate for stronger federal and state laws against the perpetrators and for the victims.

Human trafficking is modern day slavery and the number of victims worldwide is staggering. Janice will also show a DVD of the story of Theresa Flores. Her book, *The Slave Across the Street*, tells her story of a young 15 year old girl in the Detroit suburbs who became one of its victims. This book is available at Barnes & Noble and on Amazon. She will have them available for \$12.00 at the meeting.

The business meeting at our April Convention is very important to AAUW of SC's future.

This past year, your state Board has been looking at how we function as a state organization. Our main concern is that we have been finding it increasingly more difficult to fill key leadership positions. A committee of four board members – **Bev** James, Pat Hall, Ann Terry and myself was formed over the summer to make recommendations to the Board. Their

recommendations went to the full Board for its approval at the winter meeting..

The committee looked at other state structures and did a thorough review of our current bylaws. The consensus was that we needed a more stream-lined structure and a bylaws revision was needed to accomplish this.

A new state structure has been proposed focusing on fewer elected positions with several key committees handling the work of the state.

The new structure allows for an elected President, Finance Officer and Past President with appointed committees to handle the functions of Advocacy, AAUW Funds, Communications, Member Support,

Nominations and State Meetings. Chairs of these committees will serve on the Board with someone selected from the Board at each meeting to record minutes. Board terms will be two years with a biennial convention in the even years

The new bylaws also include those mandated changes from the recent AAUW convention, along with changes that bring AAUW of SC into compliance with SC State Code.

AAUW's Tradition of Advocacy Continues – "Together We Break the Silence"

Legislative Action Day featured speakers & workshops

This year Legislative Action Day was held at the Epworth Children's Home in Columbia, jointly sponsored by AAUW, The United Methodist Women, Church Women United and The SC Coalition Against Domestic Abuse.

Entitled *Together We Break the Silence*, the issues discussed at the conference were very compatible with AAUW public policy issues.

Dr. Mitchell Zais, State Superintendent of Education, gave the keynote speech in which he discussed the values he brings to public education in SC. He firmly believes that *every* child can be taught but that schools are "school" centered not "student" centered. He likes a variety of approaches and supports magnet, charter, home schooling and tax credits for public schools. Some of these policies AAUW would oppose. He also would give tax credits to businesses who would give scholarships to poor students for private school tuition. He feels that good class room teachers need to be paid much more and poor teachers less and that there has been too much growth in payroll for administrators and not enough for teachers. He would also copy the European model of allowing students/parents to select alternative education paths after

eighth grade so that everyone is not forced into the eighteenth century model that puts almost all students in a college preparation path. He has never supported vouchers. Members of the audience took issue with some of his ideas.

I attended the workshop on Domestic Violence and learned that the state budget addressing this problem has been cut by 35% and efforts are being made to restore the funding. You may go to the website www.pjacobs@sccadvasa.org to investigate legislation on this vital issue for women. I was stunned to learn that women on average return six times to abusive husbands before leaving and that domestic disturbance calls are the most dangerous calls police receive. Abusive men often display such anger that they will kill anyone who gets in their way.

The women in the conference seemed united in their wish to support public education and equal treatment for all citizens.

Please respond to our many e-mails to defeat legislation that would suppress the right to vote in our State. We will keep the bulletins coming which we hope you will pass along to all of your members and other interested parties.

My first experience at Legislative Action Day

Martin Luther King, Jr. had a dream that changed all our lives; but now we have the *DREAM Act* languishing in Congress and a plethora of anti-immigrant bills in State legislatures, including South Carolina.

Reverend Emily Scales Sutton led a workshop entitled *There are strangers among us* challenging women to engage in hard conversations about immigration fears and concerns; strengthen local education and advocacy; and view migrants as undocumented human beings, rather than as "illegals."

The Obama Administration has strengthened immigration enforcement without succeeding in fixing the broken immigration system. Every year 650,000 undocumented students graduate from high school in the United States without hope of going to college, getting a job, or even a driver's license in the only country they have ever known.

The separation of immigrant families is at crisis levels, while more funds are being spent on immigration enforcement, expansion of detention and deportation.

According to Reverend Sutton the key areas for advocacy on immigration are:

- Call on the Obama Administration to end deportations and detentions until the broken immigration system is fixed;
- Contest state efforts to set immigration policy or impose restrictive laws affecting the migrant community; and
- Challenge Department of Homeland Security ICE programs that enlist local police in immigration enforcement leading to detention and deportation of migrants who have committed no crime.

According to the Southern Poverty Law Center, there are 55,000 (1.2% of total population) undocumented individuals living in South Carolina. An anti-immigrant law has been passed by the SC Legislature that would allow police to demand "papers" from individuals stopped for traffic violations, and criminalize everyday interactions with undocumented individuals. Federal judges have blocked enacting the law until a U.S. Justice Department lawsuit against it is resolved.

Make your branch treasurer's duties a lot easier – sign up for AAUW's Membership Payment Program

With just a few easy steps, individual branch members or finance officers can have the ability to pay dues online. The state of South Carolina opted-in to the Membership Payment Program enabling individual branches to also opt-in. With the opt-in, the Association has provided this simple, convenient and efficient method for paying dues. Congratulations to Charleston, Rock Hill, and Gaffney who have already opted-in!

Branch Treasurers or Finance Officers or Branch Presidents may complete the form available on the Member Database for Branch Opt-in. This form can be found by clicking into the *Member Center* using your member number (found on the label of the Outlook or you can locate it yourself by clicking on **locate it.**) Once members are in the *Member Center*, they may access the *Member Database* by using your member number and creating a password.

Whichever officer is completing the opt-in process, once they are in the database, click on the *Branch Opt-in* on the left

sidebar. To complete the opt-in, you will need the account number of the branch's bank account and the amount of state and branch dues. Simple as that!

Once the Branch Opt-in is in place, the Finance Office can obtain help by clicking on the *Master User Guides* found on the upper right. The guide *Branch MPP Dues Payment Entry* will very specifically lead the Finance Officer through the process of submitting dues. Finance Officers can collect dues from branch members, complete the form and send a check to the Association. The branch dues will then be deposited into the branch account, the state dues into the state account.

Individual branch members may also pay their dues online by credit card once their branch has opted-in. Once again, branch and state dues will be deposited by the Association into the correct account. So easy!

Check out this AAUW Program in a Box: Woman-to-Woman Voter Turnout

What is the program?

This workshop covers the components of planning and implementing an effective campaign to turn out women to vote. The training utilizes AAUW's well-received guide, *Woman-to-Woman Voter Turnout: A Manual for Community-Based Campaigns to Mobilize Women to Vote*, which provides step-by-step instructions and examples for leaders as they plan and implement a campaign of personal, woman-to-woman outreach that will turn out women voters. Copies of the manual should be distributed to every participant so that each can follow along. Printed copies of the manual can be ordered from AAUW or the complete manual can be downloaded from the AAUW website.

The *Woman-to-Woman Voter Turnout* manual provides guidance on how to personalize voter turnout campaigns to the resources available in a community to have a lasting effect.

How will this program benefit your branch or community?

A Woman-to-Woman Voter Turnout campaign in a community will:

- increase the influence of women on the outcome of elections and policy-making;
- increase the visibility of AAUW in a community and recruit members; and
- develop leadership skills of AAUW members.

How can you implement this program?

Use the Woman-to-Woman Voter Turnout program in a box to conduct a successful Woman-to-Woman Voter Turnout training workshop or conference in your community. Simply

download the components of the Box and follow the Program Guide as you "unpack" the box's resources and customize them for your own use. Each Program "box" contains a number of components:

Program Guide, including:

- How to use the Woman-to-Woman Voter Turnout Program in a Box
- Meeting location arrangements; AV checklist; typical room set-up with classroom seating (or however); speakers
- Local sponsorship opportunities; fundraising opportunities
- Membership recruitment; retention opportunities
